BUILDING HEALTH IN THE CHURCH THROUGH EDUCATION



SLIconnect, the education ministry of Saint Luke Institute, supports the spiritual and psychological development of men and women in church ministry through practical, skills-based online courses, in-person workshops, and online and print publications. In 2019, our education programs reached over 4,000 men and women world-wide. Our high-quality resources for healthy, sustainable ministry help ministers nourish and develop their own strengths so they can minister more effectively to others.

Online: Changing the Culture of Continuing Formation

SLIconnect monthly webinars cover a wide range of critical topics in spiritual and psychological health, including ministering to difficult personalities, embracing transition, leading with emotional intelligence, managing anxiety, building resiliency, and more. Live online presentations are recorded so busy ministers can watch on their own schedule. Our growing course library has over 130 hours of content—faithful to Catholic teaching and focusing on ever-important skills for human formation—increasing our capacity to relate to and be in service to others.



Since 2012, dioceses, religious communities, and seminaries have been using SLIconnect to help priests and religious cultivate the psychological and spiritual wellness, interpersonal, and pastoral leadership skills they need to thrive in ministry. For an annual fee, nearly 40 dioceses, religious congregations, and seminaries worldwide receive unlimited access to our course library and online publications, providing their priests and community members with convenient, affordable access to continuing education.

In Person: Sharing Our Expertise to Strengthen the Church

In 2019, our team of expert clinicians and spiritual formators offered over 60 in-person workshops to men and women in ministry. These included seminaries in China, Rome, and Mexico, the annual gatherings for the Conference of Major Superiors of Men, the National Conference of Diocesan Vocation Directors, the Leadership Conference of Women Religious, and the National Religious Vocation Conference. Saint Luke Institute also offered diocesan study days, priest convocations, retreats, and other educational workshops around the world.

DAY BY DAY: Intensive Outpatient Treatment

Effective behavioral health treatment begins with a comprehensive evaluation conducted by skilled and experienced clinicians. Understanding the nature and depth of the presenting issues in view of the whole person allows for an accurate diagnosis and the determination of the least restrictive environment for the type of care needed.

Only those with the most serious type and level of illness require 24/7 residential treatment. The Intensive Outpatient Treatment program at Saint Luke Consultation Center in St. Louis, Missouri—also known as a day-treatment program—provides high-quality care.

Saint Luke Consultation Center assists with housing through the generous hospitality of local religious communities or parishes who can offer short-term

communities or parishes who can offer short-term housing during treatment. The clergy and men and women religious treated must be able to commute to the

center, and most importantly, be safe in an outpatient environment and not at risk of self-harm or harm to others.





Program Components

This six-month Intensive Outpatient Treatment program offers many of the services typically found in a residential program, but is well-suited for clients not in need of 24/7 nursing or observation. This interpersonally focused and psychoeducational treatment is offered five days per week, Monday-Friday.

Clients participate in both group and individual therapy along with spiritual direction. Group sessions address a wide range of issues, depending on the needs of the clients in attendance. Individual

therapy and spiritual direction are augmented by psychoeducational workshops held twice a week. Led by a clinician, topics may include anger management, assertiveness, mindfulness, boundaries, interpersonal skill development, and/or celibacy.

Progress and Feedback

Client progress is tracked monthly, and a mid-term written evaluation is provided. At program conclusion, a discharge conference is held with the client, therapeutic staff, and the superior/referring contact person. Recommendations for maintaining progress and follow-up care are also provided.



Continuing Care

Clients who complete the program are encouraged to participate in aftercare workshops held twice a year. These sessions offer an ongoing community of care, and time for clients to evaluate their transition from treatment to ministry or other living situations.

Additional follow-up care includes individual and group therapy at our center in St. Louis, specifically tailored for individuals who have completed the Intensive Outpatient Treatment program, or therapy through Saint Luke Institute, or other treatment programs.
